<u>Certificate of Final Completion – DHCD Project #113076- Cement Sidewalks:</u> Commissioner Leonard motioned and Commissioner Parks seconded a motion to approve the Certificate of Final Completion for the DHCD project #113076 – Cement Sidewalk project. The final payout for retainage in the amount of \$6,834.55 closes out the project at \$136,690.94.

Amendment to the Greenfield Housing Authority Smoking Policy: Commissioner Parks motioned and Commissioner Leonard seconded a motion to approve the Amendment to the Smoking Policy. The amendment stipulates smoking shall be prohibited within twenty-five feet of all buildings, effective July 1, 2020. Effective January 1, 2020, smoking shall be prohibited in all locations on Greenfield Housing Authority properties. The amendment also details what is considered as smoking.
