**Fair Market Rents and Payment Standards:** Director of Leased Housing, Ann Borkowski, presented the Board with the recent FY21 Fair Market Rents. The Housing Authority will be setting their FMR rates for FY21 which can be anywhere between 990% to 110% of the HUD established rate. The Board will be voting to approve the GHA FMR rate at an upcoming meeting.

**DHCD Public Housing Notice (PHN) 2020-29:** DHCD is awarding \$324 per 667, 200 and 705 unit which totals approximately \$76,000 for the GHA. There is additional HUD funding through the CARES Act of approximately \$240,000. Finance Director, Jodi Clough, estimates that we have spent \$44,000. Some of the funds will be directed to adapting the Conference Room for public use, replacing carpet with vinyl flooring, ventilation system upgrades, PPE and sanitation.

**GHA Mission Statement:** Work has started on updating the Section 8 Admin Plan. One important component at the beginning of the Admin Plan is the Mission Statement. Presently, GHA has a "canned" Mission Statement that Nan McKay uses. Director of Leased Housing, Ann Borkowski, has requested input from the staff and the Board in the coming weeks for any changes or additions to the Mission Statement.
